### Wish Trip Starter Blueprint

#### 1) What This Is

- Allergy or accessibility notes you choose to share

Payment information:

- Payments are processed by third-party providers
- We do not store full credit card numbers

Usage data:

- Basic analytics such as page views and clicks to improve the Product

### 2) How We Use Your Information

We use your information to:

- Deliver digital guides and planning materials
- Provide customer support and updates
- Process payments and send receipts
- Improve our products and services
- Send occasional marketing related to Wish trips, alumni travel, or custom trip planning

We do not sell your data.

### 5) Data Retention & Security

We retain planning records only as long as needed to deliver services and meet legal or accounting obligations. After that, data is deleted or de-identified.

We use reasonable safeguards, but no system is completely secure.

## 6) Cookies & Analytics

We may use cookies or analytics tools to understand how the Product is used and to improve content. You can manage cookies in your browser settings.

## 7) Your Choices

You may:

- Request access to or correction of your information
- Unsubscribe from marketing communications at any time
